## OVERVIEW

The Innovator All-World Hedged Equity Model Portfolio seeks to provide broad based exposure to the global equity market, while reducing volatility. The strategy invests in proprietary Defined Outcome ETFs™ with a built-in buffer. The model is rebalanced back to the target allocations on an annual basis in an effort to provide a balanced risk profile, tilted toward growth, over time.

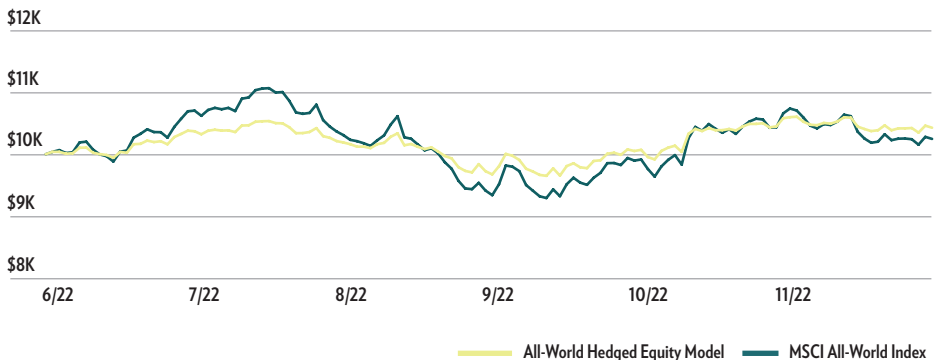

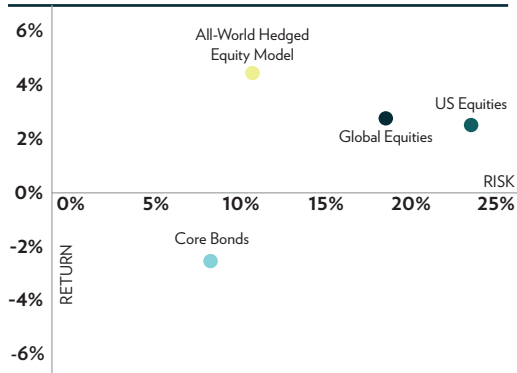

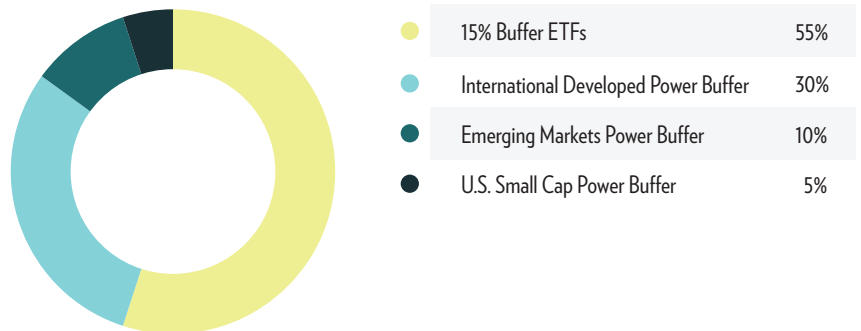

## STRATEGY DESCRIPTIONS

Floor ETFs™ seek to provide the upside performance of a reference asset, to a cap, and a maximum loss of 5% or 10% over the 3-month outcome period.

S&P 500, is a stock market index tracking the stock performance of approximately 500 large companies listed on stock exchanges in the United States.

Defined Outcome Buffer ETFs:

The outcomes that a Defined Outcome Buffer ETF seeks to provide may only be realized if you are holding shares on the first day of the Outcome Period and continue to hold them on the last day of the Outcome Period, approximately one quarter. There is no guarantee that the Outcomes for an Outcome Period will be realized or that a fund will achieve its investment objective.
